From February 2010 to November 2011 Przedsiębiorstwo Remontowe "PAK SERWIS" Sp. z o.o. seated in Konin performed for Przedsiębiorstwo Serwisu Automatyki i Urządzeń Elektrycznych EL PAK Sp. z o.o. building, assembly, disassembly and installation works within the task "**Reconstruction of main pump station no 1 and 2 at Pątnów power station**".

The scope of works included:

- necessary building works, including refurbishment of rooms, floors, cable ducts; delivery and assembly of sewage, heating and ventilating systems
- disassembly and assembly of a new drainage system, technological water to remove waste in pump stations no 1 and 2 and valve chambers
- disassembly and assembly of encasing and drives of rotary sieves along with ancillary devices
- disassembly and assembly of flange throttling valves, valves and compensators DN1800 PN6
- painting of pipelines with anti-corrosion epoxy coating, laminating of inner surfaces
