The decision granted by UDT Ostrów Wielkopolski Branch No. UC-17-54-N/2-02 of 30 December 2002 regarding authorisation to produce elements is hereby repealed.

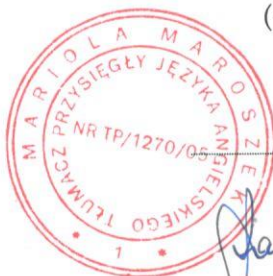
